# MINUTES HAZLETON CITY COUNCIL REGULAR MEETING TUESDAY, NOVEMBER 12, 2024

**Call to Order:** Council met in a Regular Meeting session on Tuesday, November 12, 2024 in Council Chambers. The meeting was called to order at 6:01 p.m.

**Silent Meditation and Pledge of Allegiance:** A silent moment was taken followed by the Pledge of Allegiance.

**Minutes of Previous Meetings:** The minutes of the October 8, 2024, Regular Meeting were approved unanimously.

Presentations/Proclamations/Communications: Oath of Office was given to incoming Junior Council Members

Ondishin gave the Oath of Office to all incoming Junior Council members.

Bid Opening: None

**Courtesy of the Floor (ON AGENDA ITEMS ONLY)**: Dee Deakos, 43 Mine Street, Hazleton, spoke of Resolution 2024-50. She asked what market lease is the City talking about. Ondishin said this references to the evaluation of HCA.

Allison Leonard, 107 Franklin Street, Hazleton, spoke of Ordinance 2024-21. She asked what ordinance this clarifies and is it included in the agenda packet. The City Clerk said no, the past ordinance is not included in the agenda packet.

Atty. James Brando, Slusser Law Office, said he is here, tonight, to represent his client, Regina Fisher. He said the ordinance is Ordinance 2024-17.

J.T. Klein, 226 E. 1<sup>st</sup> Street, Hazleton, spoke of Ordinance 2024-21. He said "they" still have a guy who cannot get a pension check, but the City wants to change the pension ordinance.

#### On the Question:

Mayor Cusat said in the 2002 Code Book, all of the City pensions were eliminated from the Code Book. He said the City "pulled" all of the City pension ordinances, back to 1939, re-typed them, and "red-lined" them. Mayor Cusat said the City will put back all the pension ordinances back into the 2022 Code Book. He said this process will be completed by 2025. He stated no changes were made. He stated the pension ordinance will be in one chapter.

Nilles said this gives all the City unions three weeks to come back and discuss any issue. Mayor Cusat agreed.

J.T. Klein asked why the City's pension board cannot review this ordinance. Mayor Cusat said the City's pension board is an investment board. Allison Leonard said if there are questions, this ordinance should be tabled.

Ondishin stated it would be good to "go" on the first reading and "get it moving". Bruno said there is still time for any City union to review the pension ordinance.

An audience member stated the police and fire unions are not happy. He asked if Mayor Cusat will send this to the City union president's. Mayor Cusat said he will send an email to all union presidents.

Nilles stated there are thirty "some" documents, in the pension file, and the City is putting them into one ordinance.

Mayor Cusat stated he wants to get this process done for the pensions to be in the 2025 City Codification Book.

Mayor Cusat said the funds will be used for the basketball court, playground and soccer areas.

#### **RESOLUTION PASSES 4-0**

New Business: Dan Lynch presented the City of Hazleton's 2025 proposed budget.

Lynch said there will be no action taken, tonight, on the City budget, only a budget presentation.

He said the 2025 budget proposes a real estate tax increase of 1.531 mills, or 18.8%. He said the 2024 real estate tax increase was 20.2%, 2021 real estate tax increase was 9.7%, and in 2018, it was 20.2%. Lynch stated there are a number of reasons that are "driving" this proposal. He said the first is a drop in total revenue. The net drop in revenue is \$372,000. The City's 2018 loan through the Redevelopment Authority required "balloon" payments at the end, and in 2025, it is the City's largest payment of \$172,000. He said the mills would need to be increased to .19 mills. Lynch said the Hazleton Police Department Flock camera system was purchased through grants, but the grant has expired. He said the City would need to pick up this cost. He said, also, inflation and the cost of health care costs, for the City employees, has increased by 15% (\$330,000) to over \$2,000,000 a year.

Lynch said the City has seen steady growth of City tax collections. He said the earned income tax has increased about 33% since 2020. He said the PPT tax has shown some growth.

Lynch said the City's COP's grant will expire. He said this is a five-year grant. Lynch said with the original agreement, the City would need to pick up the costs, of the police officers, in years four and five.

Lynch stated the Hazleton City Council elected, in 2016, to take an early payment, form the HCA, for their services, and took the 2025 payment in year 2016 of \$450,000.

Lynch said there are contractual pay increases, for City employees, at 3%, except for the Hazleton Fire Department increase is 2%.

Lynch said the City reduced the ACT 205 EIT tax by 50%.

The City has a total taxable assessed value of \$1,012,898,700. The proposed budget assumes a collection rate of 90%. There are 9,926 unique parcels in the City. The median assessed value for City properties is \$76,400.

Lynch stated the breakdown of \$1.00 of real estate tax is .90 cents goes to the General Fund, 2 cents goes to recreation, and 8 cents goes to debt service. For the 90 cents going to the General Fund, 0.9 cents are for General Administration, 0.39 cents for the police department, 0.19 cents for fire department, .20 cents for DPW, and 0.10 cents for parking, code, planning & zoning insurance.

Lynch said with the City taking the early \$450,000 HCA payment, in 2016, and with City Council neglecting to properly fund the 2017 budget, the City needed to enter ACT 47 in 2018.

Old Business: None.

**Comments from the Audience:** Dee Deakos, 43 Mine Street, Hazleton, said the City does a lot of LSA grants. She stated that the City needs more LSA's for public safety. She said there are a lot of alleys without a stop sign, streets without street signs, parking that goes all the way to the corner, and a lot of the intersections to "push the button" are not working.

J.T. Klein, 226 E. 1st Street, Hazleton, said he stands here, tonight, with his brothers of the Northeast PA Professional Fire Fighters Union, along with the Hazleton Police Department. Klein stated John Leshko, who retired in May with 20 years of service to the City, has not received a pension check yet. He, recently, had a massive stroke. He stated John needs to receive the money he earned. Klein stated Mayor Cusat receives a 3% unlimited longevity pay along with an "unbelievable" health insurance plan.

**Comments from Mayor:** Mayor Cusat thanked everyone for being at the meeting tonight. He stated he understands the pension discussion is "touchy' and this cannot be discussed in public because it is a personnel issue.

Mayor Cusat said the City Christmas Tree Lighting and Santa parades will be done before the next City Council meeting.

Mayor Cusat wished everyone a Happy Thanksgiving.

Comments from City Administrator: None

**Comments from Junior Council:** Nilles asked Lynch where the City is at with the audits. Lynch said the 2021 audit is "wrapping up" and the 2022 City audit is underway and "moving along".

Nilles asked if there is, currently, any activity at the old St. Joseph Medical Center. Atty. Logsdon said no.

Nilles said he noticed the parking sticks being installed, one at Laurel and 5<sup>th</sup> Streets. Mayor Cusat, said currently, there are 20 parking sticks installed. Nilles asked for a list of all City locations that have the parking sticks installed.

Nilles wished all veterans a Happy Veteran's Day.

Ondishin thanked all veterans for all they do.

Adjournment: Ondishin motioned to adjourn the meeting. The meeting was adjourned at 7:26 p.m.
